 Traffic calming measures, possible one-way system LDC /ESCC/Cradle Hill Business Sub -SCP to write to Chief Executive,LDC to enquire if a traffic consultant could be appointed to investigate solutions to various concerns raised by occupiers about traffic dangers including pinchpoints, lack of warning signs.- in han4
- 4)-Investigate Footpath Improvements to Estate -Seaford C.P.Transport Sub Group /LDC/ESCC

- Investigate potential to encourage more cycling to the estate with objective to link estate via "safe cycle routes" into comprehensive safe route infrastructure. serving the Seaford area. LDC to advise how best to build this vision into the wider plan for improving cycling infrastructure in Seaford.
